Waiver, Authorization and Release

In order to participate in any Table Tennis league or event, you must read and sign this Waiver, Authorization and Release.

As a condition of the participation of the undersigned in any and all of the Middlesex Table Tennis leagues and/or events, operated by Daniel Tessier or Middlesex Table Tennis Club, the undersigned, on behalf of himself/herself, his or her family, heirs, executors and legal personal representatives:

- (i) fully assumes all risks, dangers and hazards and possibility of personal injury, death, property damage, expense and related loss, including loss of income, resulting from my participation in the sport of table tennis and the activities, events and programs of Middlesex Table Tennis Club, caused in any manner whatsoever, including, but not limited to, the inherent risks of participation in sports, breach of contract, breach of statutory duty of care, or negligence of Middlesex Table Tennis Club or Daniel Tessier, or their respective employees and agents, as applicable (the "Releasees"); and
- (ii) agrees that the Releasees shall not be liable for any such personal injury, death, property damage, expense and related loss, including loss of income;
- (iii) forever releases the Releasees from any and all liability for any and all claims, demands, actions and costs that might arise out of my participation in the sport of table tennis and the activities, events and programs of Middlesex Table Tennis Club and waives all claims against the Releasees;
- (iv) authorizes Daniel Tessier, Middlesex Table Tennis Club, and their respective representatives, licensees and other agents, to use film photographs, digital photographs, motion picture footage and audio recordings of me, along with my name (collectively, the "materials"), for promotional purposes of Middlesex Table Tennis Club or any other purpose whatsoever, including in any manner of media, including social media, on their website, and through other publicly posted materials, without remuneration, in any geographic jurisdiction, at any time and from time to time;
 - (v) waives any right that I may have to inspect and/or approve the form, format or use of the materials or the advertising or promotional material that may be created or used in connection therewith, or the use to which it may be applied, and irrevocably assign any copyright in any and all promotional materials utilizing the material to Daniel Tessier, Middlesex Table Tennis Club;
 - (vi) releases and discharges the Releasees and Middlesex Table Tennis Club and their respective employees and agents from any claims arising out of the use by them of the materials, including, without limiting the generality of the foregoing, claims for libel or invasion of privacy .

The undersigned confirms that he/she:

- (i) is eighteen (18) years of age or older;
- (ii) is participating voluntarily in the sport of table tennis and the activities, events and programs of Middlesex Table Tennis Club;
- (iii) is aware of the risks, dangers and hazards associated with or related to the sport of table tennis and any such programs, activities and events conducted by Middlesex Table Tennis Club, including severe injuries or even death; and
- (iv) has read and understood this Waiver, Authorization and Release.
